Applegate Trail (*Trail*) GLO Surveyed Points Of Interest (POI)¹

Trail **POIs: 1850s** Except as otherwise noted in individual *Trail* POI brochures, Hugo's POIs program starts with the identification of POIs for the *Trail* as identified from the GLO surveys and maps.¹ http://www.jeffnet.org/~hugo/applegat.htm. Hugo's two 1850s GLO *Trail* emigrant routes are located in Josephine County, Oregon from Louse Creek in the south to Grave Creek in the north.

- JACKSONVILLE ROAD (JA) from Willamette Valley to Jacksonville (route of the Applegate Trail)
- ILLINOIS VALLEY (IV) ROAD to Illinois Valley via Van Noys Ferry (route of the Applegate Trail from Widow Niday's place to ferry location on Rogue River

There are 33 identified GLO POIs on Hugo's two emigrant routes.

MET Program The foundation for Hugo's 17 digit POI code is the Oregon-California Trails Association's (OCTA) mapping emigrant trails (MET) program.⁴ The MET coding system comprises six letters or numbers: the first two designate the state (OR), the second two designate the trail name (Applegate Trail = AT), and the third two are the sequential numbers of the USGS quadrangle map within the state which the OCTA has not yet assigned for Oregon's quadrangles. Without OCTA map codes for Oregon's quadrangles, Hugo's default sequential USGS quadrangle numbers are "00".

Diaries, Journals, & Reminiscences²

Eleven (11) more letters and numbers were added to the OCTA's six map codes: 1. codes for township, range, and section (i.e., first section identified in GLO survey), 2. true direction of survey line run, N, S, E, or W between sections, 3. trail route (i.e., JR or IV Road), and 4. sequential trail number. Finally, the common name for the POI is identified along with the 17 digit code. The following is an example POI for OR-AT-00-35-05-30-E-JA-01: Louse Creek Prairie.

- AT Applegate Trail
- 00 Default USGS Quad Number
- 35 Township 35 for Willamette Meridian (WM)
- 05 Range 5 (WM)
- 30 Section 30 (of T.35.S., R.5W. of WM)
- E True line run East direction between sections
- JA Jacksonville Road of Applegate Trail
- 01 First POI along JR from the South

There are three other introduction POI brochures to the individual POI brochures: 1. JR POIs; 2. IV POIs, and 3. House POIs.

General Land Office (GLO) Surveys & Maps³

Diaries, Journals, and Reminiscences will be used in the individual POI brochures as applicable.² For example, in 1846 diarist Virgil Pringle wrote:

Friday, October 16 - Cross the Rogue River about 4 miles from the last camp. Ford good. Camp on right bank.

Saturday, October 17 - Travel 8 miles, road good and a good camp which is not common, the country being mostly burnt. 8 -2,218 miles

Be Respectful. Do not trespass. Always be respectful of your neighbor's property rights. With permission, leave only footprints.
