Jacksonville Road (JR) Of Applegate Trail (*Trail*): Postal Telegraph (PT) Line¹

Hugo's JA from Willamette Valley to Jacksonville (route of the Applegate Trail) is located in Josephine County, Oregon from Louse Creek in the south to Grave Creek in the north. There are 17 GLO surveyed points of interest (POI) along the JR in Hugo's area of interest.³ There are many more like this *1886 - 1887 PT Line At Mt. Sexton Pass POI* without a GLO survey.

1886 - 1887 PT Line Howard Banks, Insulator Expert⁴, identified a down pole at the south end of the road segment as a PT pole part of a line from the 1886 - 1887 when everything was pole to pole (see Photo 1 on title page).

CD 133 Star

The original insulator for the PT line was the Brookfield CD 133 Star. A wide variety of insulators were being used on the system when it was abandoned at the end of WWII: CD 145 California (CA), CD 208 CA, CD 210 CA, CD 154 Maydwell, CD 154 Whitall Tatum, CD 153 48-40's (Gayner), and others.

PT Line At Mt. Sexton Pass: 1876 - 1878

Postal Telegraph Company formed in 1881 to compete with Western Union. It capitalized on the email technology of its day. Telegrams were sent to destination offices, and then mailed to private and business recipients. Going "postal" was routine business for this telegraph company. Using local mail delivery still made it possible to transfer messages much faster than long distance mail. The concept was an immediate success, and PT went international in 1886.

Lines were built through Josephine County around 1886 - 1887. It was a smaller company that found a

niche in the marker. Its niche was taking care of the little guy. For example, Western Union might be the only telegraph line providing service to your area. If you lived in Merlin or Grants Pass you could get telegraph service (somehow you would be notified if you had a telegraph line). If you lived further into the country, forget it.

The PT Company was set up to utilize both the telegraph and the post office. A telegraph might be sent from Iowa to Merlin, Oregon. At this point the telegraph would be mailed from Merlin to the family in Hugo. So now, all the little folks in the country could now get telegraphs, or send telegraphs by using the mail system. There were PT offices clear up to Prospect, Oregon. They covered a wide market. Later on Western Union also used this method.

Six-Pin Cross Arms The PT company operated the line until they had six-pin cross arms. The neat thing about the postal line was in the middle of WWII they merged with Western Union and the lines were left in place and they disintegrated into the ground.
