Jacksonville Road (JR) Of Applegate Trail (*Trail*): **Big Tree Aged**¹

Hugo's JA from Willamette Valley to Jacksonville (route of the Applegate Trail) is located in Josephine County, Oregon from Louse Creek in the south to Grave Creek in the north. There are 17 GLO surveyed points of interest (POI) along the JR in Hugo's area of interest.³ There are many more like this 2010 Big Tree At Mt. Sexton Pass POI without a GLO survey.

2005 Big Tree On April 6, 2005 Virgil Witcher⁴, Consulting Professional Forester, aged a large Douglas Fir tree (dbh 33") at 75 years with wound wood close to the middle of the Trail at Mt. Sexton Pass His hypothesis about wound wood and injury makes Big Tree much older. In 2010 Big Tree might be the same age of 107 years old as a nearby fir that Witcher believes is a cohort.

Big Tree From 80 - 107 Years Old: 2010

The purpose of the field trip was to age Big Tree by boring and counting it's annual rings. Witcher used a 16" long increment borer. All rings had good growth. There were 70 annual rings from the bark and cambium to the center of the tree at the pith. The number of annual rings and adding five years would normally indicate Big Tree was 75 years old in 2005.⁴



Witcher believes that **Big** Tree probably had injuries when it was small from wagons and/or motorized vehicles driving over it. It was probably injured many times. The

limbs/stubs from one to 5 feet from the ground on the tree. When the injuries first occurred there had been enough living tissue to supply the limbs with water and the injured limbs continued to live. The tree grew around the injured limbs and absorbed them. Because of the injuries the limbs do not slough off and become persistent forming stubs on the outside of the tree.

In 2005 another Douglas fir tree 25-30 feet uphill from tree from Big Tree was also bored. The core had 95 annual rings plus 7 equals a 102 year old tree. This tree is not as big as Big Tree, but probably a cohort and the same age.

No Wagons Or Motorized Vehicles At Mt. Sexton Pass Since 1920s

Summary In 2010 Big Tree was from 80 to 107 years old and started growing from 1903 - 1930. The wound wood strongly suggests that a young Big Tree was being traumatized by wagons and early motorized traffic prior to a new Pacific Highway being paved in 1921 and the old *Trail* being abandoned. Either way Big Tree proves the roadbed is not some recent logging road. It is old, has not been used by wagons or motorized traffic since the 1920s, and highly likely the evolution of the old 1853 Military Road.
