Mt. Sexton Pass 310' *Trail* Segment has reliable linear uniformity.
- Linear orientation and uniformity of GLO point of interests (POIs) JA-14<sup>4</sup> & JA-15<sup>5</sup> on both sides.
- Road orientation/course and uniformity for previous and following GLO POIs.
- Linear road orientation of physical roads (i.e., North-North Oxbow Road, 310' segment of 1853 Military Road<sup>6</sup>; Old Stage Road).

Sexton Pass 310' *Trail* Segment has reliable GLO maps.
