James Twogood & Stage Company

1852 James Twogood "filed for land claim #37 on May 1, 1852, in Jackson County. Later when Josephine County was laid out this area eventually became part of it. Thus, James Twogood, at age twenty-five, was the first land claimant of Josephine County and the founder of the Grave Creek Ranch and the original Leland."¹ p. 2

1853 Military Road Brevet Major B. Alvord, United State Army, located and surveyed the 1853 Military Road from Myrtle Creek to Jacksonville, Oregon²⁻³ which became the overland road.


1853 Grave Creek Stage Station "On March 28, of 1855, McDonough became the first postmaster of the newly created Leland post office. Prior to the establishment of the post office, the Grave Creek Ranch was the overnight stopping place for the once a week mail carrier both south and northbound."¹ p. 5

1853 Grave Creek Stage Station "The California Stage Company out of Sacramento, California, began negotiations with Harkness and Twogood for accommodations of their stage company personnel and horses. These accommodations were to include overnight lodging and meals for stage drivers, company hostler and facilities for the care of their horses. Meals and lodging for passengers was not contracted but was provided as a convenience to the passengers who wished them."¹ p. 9

1856 General Land Office Map(GLO)⁴ The GLO map documents the Grave Creek house and the McHartles? (Harkness?) and Twogood house along the Applegate Trail.

Grave Creek Stage Station: c.a., 1853 - 18??

"The Grave Creek Ranch possessed the necessities required by the stage company and was ideally located halfway between Croxtons at Perkin's Ferry (later to become Grants Pass) and Sam Levin's Galesville near Quines Creek. Stage Company policy was to have their overnight or main stations approximately twelve to fourteen miles apart in mountainous country so as not to overwork their horses. The first mail and passenger stage to pass north through the Grave Creek Valley occurred in the later part of September of 1860."¹ p. 9

Twogood Donation Land Claim (DLC) 896

Stage Lines Connected Early Cities in southern Oregon at Canyonville, Galesville, Grave Creek, Grants Pass, Rock Point, and Jacksonville⁵⁻⁶

Hugo Region Stage Route "Stage Coach pass, the divide between Glendale and Wolf Creek, was very steep and a favorite point of operation by highwaymen. The divide between Wolf Creek and Grave Creek had a 22 percent grade, and like all other roads, was very narrow. From Grave Creek south the road skirted Sexton mountain, or Smith hill."⁷

1866 James H. Twogood DLC⁸ James H. Twogood's 159.25 acre DLC (No. 896) was patented August 7, 1866 (September 27, 1850: Oregon-Donation Act (grant) (99 Stat. 496). This was the same year that Twogood sold his 760 acre Grave Creek ranch, which included the DLC, to Samuel Harkness ¹ p. 11

1883 The business of the stageline was greatly reduced after the O & C Railroad was built to Grants Pass in 1883.
