Early Grave Creek House is best described by Larry McLane in his book, "First There Was Twogood" (see photo on title page).


"A panoramic view looking west of the Grave Creek Ranch during early staging days. The building only partially showing on the right side of picture is the Leland Creek House. The building with the stable attached is the original log wayside of Bates and Twogood."

"Homer Harkness noted in later years that he observed numerous bullet holes in this building from the Indian troubles of 1853. The Indian war of 1855 and 56 saw a stockade built that enclosed those buildings. The center building is the Oregon-California stage barn, a stage coach and team are barely visible in front of the building. The building on the far left under the Crowley oak is a blacksmith shop. Picture taken prior to 1864 as there are no telegraph lines. — Courtesy Grants Pass Courier." ⁴

Patent JA-H-4 is located on land Jimmie Twogood filed for as a donation land claim (No. 37) on May 1, 1852.⁴
