



Soils⁶ A majority of the soils along this segment of the *Trail* between JA-2 and JA-3 are 11B Brockman, 12B Brockman, and 18B Copsey. These soils have the common characteristics of being formed in alluvium derived dominantly from serpentinite or peridotite. The ultramafic rock from which these soils developed is very high in content of magnesium and very low in calcium, which limits plant growth. What this means is that the overstory is poorly developed and old roads can be seen through the trees of these soils.

Volunteer membership dues are \$10.00 annually per family and normally used for paper, ink, envelopes, publications and mailings.


