

Illinois Valley Road (IV) Of Applegate Trail (*Trail*): Vannoy DLC 1 (IV-N1A)¹

Hugo's IV Road to Illinois Valley via "Van Noys" (1855 spelling) Ferry (route of the *Trail*) is located in Josephine County, Oregon from the Rogue River in the south to Widow Niday's place in the north. There are 17 GLO surveyed points of interest (POI) along the IV Road in Hugo's area of interest.¹

C.S. 159 90 - November 26, 1990 "Plat of Survey for Mr. Davis", Located in T.36S., R.6W., Sec. 16, SW1/4, W.M., by Richard G Templin Land Surveying.

IV-N1A was plotted on C.S. 159 - 90 to be 30' south of the right bank of the Rogue River into the river channel. For locating and marking purposes off set for IV-N1A was plotted northeast of IV-N1A along a course between IV-N1A and IV-N2A as IV-N1B.

IV-N1B was located and temporarily marked 138' east (90") of the Witness Corner located on C.S. 159 - 90 in the Lechuga corn field (Photo 1). A permanent marker was placed out of the field 30 feet south of IV-N1B at new location IV-N1BA (Photo 2).

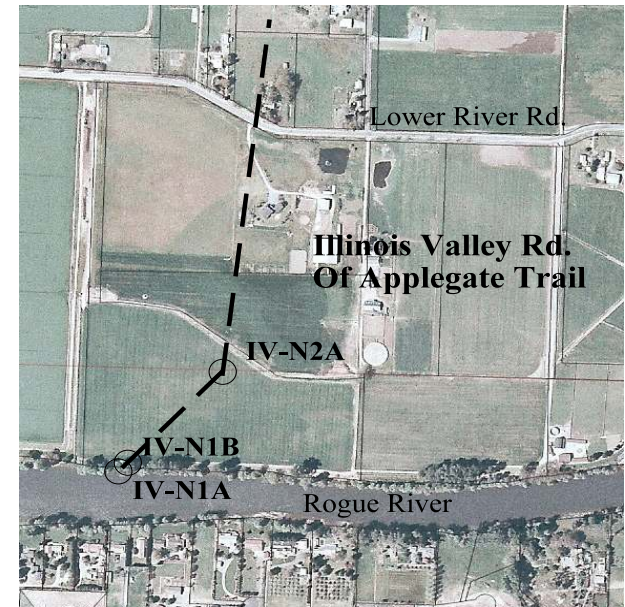
