### Hugo Tombstone Quarry Section Of Applegate

**Trail**<sup>1-6</sup> The approximate 1.5 miles of the Hugo Tombstone Quarry Section of the Applegate Trail is from the East I-5 Manzanita Rest Stop in the south to the 1880s emigrant pioneer Pleasant Valley Cemetery (PVC) in the north. This trail segment includes the *Hugo Granite Tombstone Quarry Site* and hence the name for this segment of the *Applegate Trail*.
