

1901 Albert Osborn's Hugo Homestead On May 8, 1901 Albert H. Osborn was issued a homestead certificate for 160 acres in Hugo, Oregon (Patent No. 5091). 1-2

The Osborn homestead was an important tract from the early 1880s through the early 1910s as the central location of the railroad in building and maintaining Tunnel No. 9.


