1911 — Town of Three Pines, Oregon Platted On May 30, 1911 George A. Steel and Cora Steel dedicated to the free use of the public all the land represented as streets, alleys, drives, roads, walks, and places upon the plat of Three Pines.

The Raymond Daniel Family, Early Settlers: ca., 1911 - 1910s

1911 "R. E. [Raymond E.] Daniel, [Mountain] store keeper and time keeper for the lumber company at the sawmill, had the misfortune to cut his left thumb while splitting wood Sunday afternoon. Dr. Loughridge, the physician for the National Hospital association, sent a carriage out and brought him to the South Pacific hospital. The thumb will be saved. Mrs. Daniel accompanied her husband to the hospital." *Rogue River Courier*. April 21, 1911. [Three Pines](#).

Walton S. Daniel, an employee of the Honeyman Hardware company of Portland, came down on No 19 Friday and is now at the mill at Mountain with his brother, R. E. Daniel. He will remain most of the summer. An improvement in health is the end sought by the trip here, and while the famed fountain of youth has not been located it is the opinion of many who have sampled the curative qualities of this invigorating climate that Ponce de Leon would have come nearer to realizing his ambition had he landed here instead of on the far Atlantic coast and floundering around in the miasmatic everglades in the land of flowers and mosquitoes. *Rogue River Courier*. 1911 - 1921 W. E. Daniel was Post Master for the Three Pines Post Office from the time it opened to the time it closed.

1911 "Jack Oglesby, woods foreman and R. E. Daniels, storekeeper, for the Three Pines Lumber company at Mountain, spent the Fourth of July vacation at Hell Gate fishing." *Rogue River Courier*. July 14, 1911. [Three Pines](#). "Miss Janet Daniels of Portland is spending her vacation with her brother Raymond at Mountain and with Walton at this place." *Rogue River Courier*. July 28, 1911. [Three Pines](#). "Mr. and Mrs. R. E. Daniel have returned to their home at Mountain from a week's visit with W. J. Oglesby and family of Wilderville. Mr. Daniel will engage in mining, where he and Ed Inman have secured placer ground of Geo. W. Howland." *Rogue River Courier*. December 8, 1911. [Three Pines](#).



1912 - 1917 Three Pines was recently developed and a going concern in 1912 with over a hundred citizens. By 1917 the company was in financial trouble and the town was in decline
