1883 William Willis Cash Entry Willis purchased 320 acres under Cash Entry No. 5034 in Josephine County, Oregon. It was issued March 10, 1883 to William R. Willis (April 24, 1820: Sale-Cash Entry (3 Stat. 566)).¹⁻²

Of significance is the approximately 80 acres of the 320 acres at the north entrance of the Southern Pacific Railroad's Tunnel No. 9 which was completed in 1883.

The William Willis, Early Investor: ca., 1880s - 18??


1895 By 1895 Solomon Abraham owned the 80 acres as part of 280 aces of "40s" going north covering the railroad from Tunnel No. 9.

Solomon was a merchant that had purchased 160 acres under Cash Entry No. 662 in Josephine County, Oregon. It was issued August 15, 1865 to Solomon Et. Al. Abraham (April 24, 1820: Sale-Cash Entry (3 Stat. 566)).¹⁻² This is the earliest cash entry sale in Hugo, except for the year before by Samuel Trimble. Both purchases were on the newly developed Applegate Trail. Soloman's purchase was also one of only three 160 acre cash entries in Hugo, Oregon.
