## CACNA Coalition

The Citizen Advisory Committee/Neighborhood Association (CACNA) *Coalition* is an association of land use CACs and NAs in Josephine County, Oregon. There have been several CACNA meetings in the past few years, mostly for information sharing, but there are no officers. The historical and informal CACNA agreement has been that, on a case-by-case basis, any representative of a CAC or NA could organize and call for a CACNA meeting. There was no responsibility for anyone to attend these meetings.
