**Footnote 2.** Seven sections were surveyed in the 1855 GLO survey for T.35S., R.5W., W.M. The other sections were considered unfit for settlement being high broken mountains heavily timbered. These seven sections were all in the southwest portion of the township and all subdivision lines were run true north and east (from the western boundary of the township) versus the normal method of true north and west.

**Footnote 3.** Twenty-nine (29) sections were surveyed in the 1855 GLO survey for T.34S., R.6W., W.M. The other seven (7) sections were considered unfit for settlement. These seven sections were surveyed in 1893, including JA-15 South Rat Creek. JA-15's survey line was completed true east unlike all the other subdivision lines for the township which were run true west.
