# 1800 General Land Office (GLO) & Donation Land Claim (DLC) Surveys

Hugo's Applegate Trail (*Trail*) routes of interest are generally located from Rogue River in the south to Grave Creek in the north.

- Road from Willamette Valley to Jacksonville (route of the Trail)
- Road to Illinois Valley via Van Noys Ferry (route of the *Trail* from Widow Niday's place to ferry location on Rogue River)

A problem for early surveyors was the mineral attraction in the ground deflecting the needle of their magnetic compass just enough to produce the errors. By knowing the location of the sun in relation to his position on the earth, the surveyor could adjust the solar compass for the sun's declination. On February 26, 1836 Burt's solar compass was issued patent number 9428X.

There are dozens GLO/DLC surveyed *Trail* locations for the "Road from Willamette Valley to Jacksonville" within Hugo's routes of interest. They are presently numbered JA-1 through JA-18 with many sub-sets. There are nine major "road" GLO field notes for the "Road to Illinois Valley via Van Noys Ferry" within Hugo's routes of interest. There are seven GLO field survey notes that identified houses which were close to the road, fields, prairies, and fences. The total number of locations within Hugo's *Trail* routes of interest continues to evolve.

### Purpose of General Land Office Field Survey Sub-Committee

The purpose of the *GLO SubCommittee* is to use GLO, DLC, Josephine County surveys, and other surveys within Hugo's Applegate Trail routes of interest and, ultimately, to map and mark each *Trail* location. This includes developing the methodology for translating the hand written survey notes, converting chains to feet, and plotting bearing and distances in feet on USGS topographic quadrangles. The last step is calculating the UTM and latitude and longitude coordinates from the plots on the quads (i.e., degrees, minutes, and seconds for Lat/Long). In our area of the world a second of latitude is about 100 feet and a second of longitude is about 75 feet.

One link = 7.92 inches One rod = 16.5 feet One chain = 66 feet 80 chains = one mile

The final UTM and Lat/Long coordinates will be used by the *GLO SubCommittee* with Global Position System (GPS) devices and bearing and distance measurements to locate the actual emigrant *Trail*, roads, and house locations on the ground.
