2013 Josephine County Measure 17 - 49 Tax

JO CO JS&PSS Tax Levies The 2012 expiration of federal funding in Josephine County (JO CO), used mostly for public safety services, resulted in JO CO proposing two tax levies as solutions. They both failed.

- May 2012 JO CO-wide Measure 17 43, Criminal Justice System Operations Four Year Local Option Tax (i.e., \$1.99 per \$1,000 of assessed value), failed 57 - 43 percent.
- May 2013 JO CO-wide Measure 17 49, Criminal Justice and Public Safety Three Year Local Option Tax (i.e., \$1.48 per \$1,000 of assessed value), failed 51 - 49 percent.

According to *The Grants Pass Daily Courier*¹ the Grants Pass precincts would have passed the 2013 tax (Measure 17 - 49) 59 to 41 percent and the JO CO precincts would have turned down the tax 56 to 44 percent. Overall the voting citizens of JO CO were



about half and half in supporting and opposing the measure.

All Voters &Votes Are Legitimate

HNA&HS's Core Beliefs It believes in the sanctity of freedom of speech and the right to vote and that the 2013 "nay" vote was not necessarily a vote of whether citizens supported PSS, but more a view of government and a vote on the specific measure, including its unknowns.

Freedom Of Speech in the United States is protected by the First Amendment to the United States Constitution and by many state constitutions and state and federal laws. The freedom is not absolute. However, criticism of government and advocacy of unpopular ideas that people may find distasteful or against public policy are almost always permitted.

1st - "Protects freedom of speech, freedom of religion, and freedom of the press, as well as the right to assemble and petition the government."

All Voters Of "We The People" Are Legitimate The notion of freedom of speech is intimately linked to political debate and the concept of a democracy. The U.S. Constitution protects the rights of eligible voters to vote.

- "The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State... on account of race, color, or previous condition of servitude..." 15th

 Amendment
- "... on account of sex." 19th Amendment
- "... by reason of failure to pay any poll tax or other tax." 24th Amendment
- "... on account of age." 26th Amendment

The Right Of Freedom Of Speech And To Vote Are Special

All Votes By "We The People": Ya, Nay, or Not, Are Legitimate Most democratic governments consider participating in national elections a right of citizenship. Some consider that participation at elections is also a citizen's civic responsibility. What about decisions made by democratically elected governments? Are they more legitimate when higher proportions of the population participate?

Elections make real the consent of the governed and provide legitimacy to our government. Registering to vote should be convenient and voting itself should be efficient and pleasant. Citizens should see their votes as both a right and a privilege and be proud they are citizens in a democracy.

However, voting is not an intrinsic obligation and the enforcement of a compulsory voting law would be an infringement of the citizens' freedom associated with democratic elections. Voting or not voting is a freedom associated with democracy.

All legitimate consent requires the ability to withhold consent; therefore, the legitimate consent of voters requires they be able to withhold their consent in an election to office

In summary, a yes or no vote to a proposed tax levy or not voting is a legitimate exercise of democracy.
