Josephine (JO) County (CO) Justice System (JS) & Public Safety Services (PSS)

JO CO Justice System & Public Safety Services The 2012 expiration of federal funding for services resulted in two JO CO proposed levies as a solution. They both failed.

Oregonian June 6, 2013³ It's one of the first things we learn in civics class: Governments are instituted to secure the unalienable rights of life, liberty and the pursuit of happiness. They are formed, by means of a social contract between governor and the governed, to guard against a state of nature in which life is "solitary, poor, nasty, brutish, and short." In southern Oregon, this contract between an insolvent government and a destitute tax base needs mediation.

These timber-dependent counties are caught in a time warp not entirely of their own making. While Curry and Josephine counties currently boast the lowest property taxes in the state, they also harbor a dwindling revenue base. They and others have subsisted off of the Secure Rural Schools (SRS) and Community Self-Determination Act in the years since Oregon's timber industry was all but shut down. In the wake of SRS's expiration, southern Oregon is a powerful demonstration of how addictive federal subsidies can be: Budget shortfalls sprouted as soon as the payments dried up.

Salem's plan is another hit: *House Bill 3453* would pick up half the tab for a minimum level of public services, an effective bailout of these local governments. The catch is that money from a higher, distant source -- federal or state -- is never free. It is paid by other taxpayers, as well as the same people receiving it. What's more, there are always strings attached. **Salem seizes the right to raise local income taxes without a vote of the locals**. So, residents in these counties would learn what people in Detroit already know: Home rule is not a God-given constitutional right, but a privilege extended by the plenary power of the state. In this sense, rural local governments are becoming an endangered species -- starved by their own citizens, poached by outsiders.

Oregon House Bill (HB) 3453

Oregonian June 18, 2013⁴ The county timber payments, which come from the Secure Rural Schools program, were started by Congress in 2000 to provide money for counties struggling from the loss of federal timber receipts after logging was severely curtailed on federal lands. The program expired last year, exacerbating budget problems in several rural Oregon counties. Two of them, Josephine (JO)

Salem seizes the right to raise local income taxes without a vote of the locals. and Curry, have slashed their public safety services to the point that Gov. John Kitzhaber and state legislators are working on a bill to provide emergency state aid while also imposing local taxes.

Oregonian June 29, 2013⁵ HB 3453 would authorize the governor in consultation with legislative leaders to declare a public safety

fiscal emergency and, with approval of officials in affected counties, impose a local tax to help pay for necessary services. Earlier this month, Kitzhaber said he has few options other than calling out the National Guard if an emergency develops in one of the distressed counties. The governor could assign state police to help in those counties, but that likely would require the Legislature to approve increased funding.

Oregonian July 3, 2013⁶ HB 3453 would prohibit use of a local income tax in counties where it is prohibited by local charter. That's a nod to JO CO, where such a tax is banned by the county charter.

Political Risk Of Raising Taxes Without Voter Approval

Oregonian July 8, 2013⁷ Under HB 3453, Gov. John Kitzhaber could enter into agreements with local county commissioners to raise money for additional law enforcement services. Half of the money would come from state coffers and the other half would be in the form of higher local taxes. JO CO, which has a charter provision prohibiting a local income tax, would have to look at other tax sources if it wanted state aid. Rep. Wally Hicks, R-Grants Pass, helped rewrite the bill to allow counties to raise revenue through other means, including a tax on telecommunications services.

Oregonian July 8, 2013⁸ The legislation would allow the governor to work with legislative leaders and affected county leaders to declare a public safety fiscal emergency. Once that's done, the state would provide law enforcement assistance; the county could then tax residents to pay its share of costs.

Oregonian July 10, 2013° Curry County Board of Commissioners Chairman David Smith said he hopes the southwestern Oregon county won't have to seek emergency aid from the state through HB 3453. "I believe in our citizens and I believe they understand that because of the loss of federal forest receipts we have to help ourselves," Smith said. While the state would match money raised by the county under the legislation, it also carries a political risk for commissioners who would be in the position of imposing taxes without voter OK.
