SOS's Mission Standard: To Provide A Secure JO CO

The 2013 Oregon House Bill 3453 is now law. Section 2(1) of HB 3453 provides: "If the Governor determines that fiscal conditions exist, or are imminent in one or more counties that compromise the ability of the affected counties to provide a minimally adequate level of public safety services, the Governor may proclaim a public safety fiscally emergency." We assume that SOS's "secure" could mean a minimally adequate level of public safety services. It could also mean some other higher level of public safety services, including law enforcement.

In summary, what does "secure" mean as used in SOS's mission?

SOS Frequently Asked Question (FAQ) 2. How much do we need to fund the JO CO JS?⁶ http://securingoursafety.org/qa/ ANSWER: Estimates used in last year's vote called for approximately \$12 million per year to maintain roughly the same level of services we had prior to the failed levy (functioning jail, District Attorney, juvenile justice, county sheriff). If this were funded through a permanent property tax, the rate would be about \$1.99 across JO CO (rate is per \$1,000 assessed value (AV)).

FAQ 11. Explain in more detail the current property tax system, why there is a problem, and how much would a solution to this crisis cost? ANSWER: The CO's PTR is approximately 58 cents per \$1,000 of a property's AV and everyone in the cities and CO pays this rate. Of the 58 cents, in the current year approximately 32 cents goes to Law Enforcement/Criminal Justice Services (LE/CJS). JO CO has the lowest tax rate in the whole state because federal funds used to provide the rest of the \$ to operate the CJS. In GP, in addition to the CO's tax rate GP residents pay more than \$6.00 per \$1,000 in AV, all of which goes to PSS (mostly police and fire services). While GP has a consolidated management and facilities structure for police and fire, slightly more than \$4 of the rate would be the estimated cost for LE while close to approximately \$2 would be the cost for fire services.



In summary, it is assumed that SOS's mission standard to provide for a secure JO CO is to find funding for \$12,000,000 to maintain roughly the same level of public safety services JO CO had prior to the failed 2012 levy.
