Josephine (JO) County (CO) Justice System (JS) & Public Safety Services (PSS)

JO CO Justice System & Public Safety Services¹⁻² The 2012 expiration of federal funding resulted in two JO CO proposed levies as a solution. They both failed. *"Is JO CO providing a minimally adequate level of PSS?"*

May 29, 2012 The number of **patrol deputy positions** will drop from 24.5 to six. Three of those are contract deputies, specifically assigned to patrol Cave Junction, BLM forests, and Oregon State Marine Board waterways. That leaves two deputies and a sergeant for the rest of the county.^{2A}

October 17, 2012 O'BRIEN, Ore. -- There's no room in the county jail for burglars and thieves. And the sheriff's department in a vast, rural corner of southwest Oregon has been reduced by budget cuts to three deputies on **patrol** eight hours a day, five days a week.³

May 11, 2013 County Sheriff Gil Gilbertson cut his staff from 98 to 37 and closed most of the 262-bed jail. Deputies are only on **patrol** between 8 a.m. and 4 p.m. on weekdays.⁴

1 Deputy or 0 Deputies Left, Down From 24.5

May 16, 2012 Layoff notices are due to go out this week to nearly 100 county employees, including to 70 of 98 Sheriff's Office employees; 20 of 30 Juvenile Department employees and eight of 24 District Attorney employees. The sheriff's **28-person patrol** division is expected to be cut to four: the sheriff and three deputies who by contract must patrol Cave Junction, rivers and federal forests.⁵

May 16, 2012 Voters, defeated a four-year tax proposal to fund local criminal justice programs, including jail, **rural patrol**, prosecution and juvenile department services. Gilbertson said he himself will respond to calls, with possible backup from three deputies obligated by outside contracts to patrol Cave Junction, rivers and federal forests. Oregon State Police also might be available to respond to emergencies.⁶

Chart 1: Approximately June 2013⁷ Rural patrol was technically from 22 to 3. The 3 contracted patrol deputies for the City of Cave Junction, rivers, and federal forests are not for private property rural patrol. Therefore, rural patrol for rural private property went from 19 personnel to 0 (zero).

JO CO Sheriff's Rural Patrol

June 6, 2013 Last month's defeat of two public safety levies has made the provision of essential services almost untenable. A story that went viral recently recounts how a Josephine County woman about to be burglarized and sexually assaulted called 911 and was told by the dispatcher that the county couldn't send anyone to help.⁸

June 29, 2013 Curry and Josephine have rolled law enforcement staffing back to the point that 911 calls that once would have been viewed as urgent sometimes receive responses that amount to, "Good luck taking care of yourself." Already, both counties have long stretches of time without patrol coverage.⁹

The **gaps in patrol coverage** lead to situations like one last summer that received national attention. A Cave Junction woman called 911 to report that her exboyfriend, who had hurt her before, was breaking into her house. Since no deputies were available in Josephine County, the dispatcher transferred her to state police, who offered this advice: "If he comes inside the residence and assaults you, can you ask him to go away?"

July 5, 2013 With the fiscal year that started on July 1, the Josephine County Sheriff's Office now has exactly one deputy left available for general calls in a county of 83,000 people — down from a high of 22 at full staffing a few years ago.¹⁰

Caution The number of Rural Patrol deputies can change monthly.


