## Josephine (JO) County (CO) Justice System (JS) & Public Safety Services (PSS)

**JO CO Justice System & Public Safety Services** The 2012 expiration of federal funding for services resulted in two JO CO proposed levies as a solution. They both failed.<sup>1-4</sup>

- May 2012 JO CO-wide Measure 17 43, Criminal Justice System Operations Four Year Local Option Tax (i.e., \$1.99 per \$1,000 of assessed value), failed 57 - 43 percent.
- May 2013 JO CO-wide Measure 17 49, Criminal Justice and Public Safety Three Year Local Option Tax (i.e., \$1.48 per \$1,000 of assessed value), failed 51 - 49 percent.

**"Is JO CO providing a minimally adequate level of public safety services?"** The voting citizens in JO CO are basically split on the level of PSS they want, and are able, or want to pay for. This split is not considered good or bad; it is considered a reflection on the citizens practicing their legitimate right to have differences of opinions when they vote.<sup>4</sup>

**OSU Rural Studies Program (RSP)**<sup>8</sup> Oregon State University has a PSP which is multi-disciplinary and teaches classes, conducts research and provides extended education with faculty from many colleges at OSU. The RSP has taken an in-depth assessment of the JS&PSS issue to understand the Federal forest revenue-sharing policies and State property tax policies as well as the impacts and responses of the affected counties, including changes in funding, staff, and service levels from the loss of forest land payments.

**OSU RSP: Impacts<sup>9</sup>** Participants of businesses, institutions and residents noted that the actions taken by county government in past years have resulted in heightened feelings of frustration, resentment, anger, and apathy which affect individual and community well-being.

**OSU RSP**<sup>9</sup> The OSU study is in compliance with the adequate information standards.<sup>7</sup>

The JO CO Sheriff's information is not in compliance with the adequate information standards.<sup>7</sup>

#### SOS

The SOS's information is not in compliance with the adequate information standards.<sup>7</sup>
