Opponents, Public Officials Square Off

The Constitution Party of Josephine County and the Grants Pass Chapter of the John Birch Society hosted the event at the Fruitdale Grange in Grants Pass to discuss a proposed three-year local option tax that could cost property owners \$1.48 per \$1,000 of assessed property value — about \$296 a year on a property assessed at \$200,000.

About 50 people came to the meeting to learn more about the measure, but when some in the crowd were more enthusiastic about making personal comments than posing questions to the panel, chairman of the Constitution Party of Oregon Jack Alan Brown Jr. cautioned that he didn't want the event "to be an open-air circus."

Sheriff Gil Gilbertson, Grants Pass City Councilor Mark Gatlin, and Josephine County Commissioners Keith Heck and Cherryl Walker spoke in support of the measure.

Recalled Josephine County Commissioner Sandi Cassanelli, videographer Dale Matthews and Jim Rafferty, owner of the business Hardwoods Plus and organizer of a political action committee called We're For A Constitutional Government, spoke in opposition of the tax.
