Lawmakers to discuss public safety concerns at meeting

Two state lawmakers representing Josephine County have raised questions about the availability of state aid to deal with a local public safety fiscal emergency, real or perceived.

Rep. Carl Wilson [elected January 2015] and Sen. Herman Baertschiger Jr. [Herman Baertschiger, Jr., is a Republican member of the Oregon Senate, representing the 2nd District. He was elected in 2012 and currently serves as a deputy minority leader in the Oregon State Senate.] plan to meet with local public safety officials Wednesday in Grants Pass to listen to their concerns.

The temporary state aid could be in the millions of dollars, if Gov. Kate Brown and the Oregon Legislature agree. That's a big if.

"Is the Legislature predisposed to release this much money?" said Wilson, R-Grants Pass. "It's sometimes very hard to come up with half a million."

Wilson, Baertschiger and Rep. Duane Stark, R-Grants Pass, were invited to the meeting after members of the Local Public Safety Coordinating Council two weeks ago unanimously agreed that a local public safety fiscal emergency exists or is expected to occur next year due to dwindling county payments from the federal government.

A month ago, county Commissioner Cherryl Walker proposed asking the governor to declare an emergency, invoking provisions of an untested 2013 law known as House Bill 3343. The bill authorizes an agreement between the state and a county to provide funding for up to 18 months.

But Baertschiger does not think his fellow legislators will be willing to help. "The conversations I've had is, 'You guys need to figure out how to pay for this," he said.

"Some people say we're in a crisis," he added. "I don't think we're in a crisis situation."

The support of local legislators is considered important if the state is to be successfully lobbied for the aid, but Baertschiger feels confident that a local solution can be found, despite repeated voter defeats of local tax proposals to make up for declining federal payments to the county that once were meant to offset reduced timber tax revenue.

The reduction in federal subsidies resulted in huge layoffs at the Sheriff's Office in 2012 as well as the shuttering of the county juvenile shelter/detention facility. Further cuts are feared.

"We have to take into consideration it's been voted down how many times?" Baertschiger said. "That's the direction the majority of folks in the county want to go. This is one issue the citizens want to handle themselves.

"They're problems that can be resolved," he continued. "It's going to take some time. I have more confidence in my constituents solving them than the Oregon Legislature."

Wilson said he will tell council members about his concerns.

"That bill is so incredibly vague," he said. "I have read it five, six, seven times. It says it can be construed liberally. I've never seen that wording in a bill, ever.

"I have some real concerns about the bill itself, and what the bill will create," he continued. "It creates an intergovernmental entity that is invested with power. It looks like a potential Frankenstein."
