Dear Kate:

Thank you for your agent's (i.e., name unknown, aka, Constituent Services Team, Office of Governor Kate Brown) September 10, 2015 response (Correspondence 1) to our September 2, 2015 letter/email to you (Correspondence 2), and the recommendation to contact The Association of Oregon Counties (AOC) for information. For us our letter had two main points.

Point No. 1. It shared a long-range planning attempt to understand Josephine County's (JO CO's) Justice System & Public Safety Services (JS&PSS) problem/issue, and in seeking solutions for it. We feel there are significant unique decision-maker differences between the proposed planning Study Design and the usual major impact study. For example, the end result would be credible information for informed public decision-making, not a decision by the government.

Point No. 2. It sought an understanding of the operational definition of a *Minimally Adequate Level of Public Safety Services* (MALPSS) that your office has a responsibility to determine (ORS 203.095(2)(b)) if a declaration of fiscal emergency is requested by JO CO (ORS 203.095(1)(a)). To quote our September 2, 2015 communication, "*We believe there is a real value to the citizens of JO CO, Oregon to understand MALPSS, perhaps a study identifying a range of alternative definitions for determining whether JO CO is providing the MALPSS per House Bill 3453*." Reasonable public involvement is fair procedures and notice of the rule of law written in advance, and not made up case by case without adequate public debate.

In conclusion, we felt abandoned by your office concerning any empathy for JO CO's JS&PSS Issue, and citizens' need to understand MALPSS standards. It appears to us that the Constituent Services Team is attempting to avoid the responsibility of MALPSS by directing citizens to a private organization which has no decision-making authority for implementing the applicable Oregon Revised Statutes (Appendix A).

In point of fact, we feel AOC's performance was outstanding in addressing the issue. For example, one of its strategies was funding several *termination of Secure Rural School payments to counties*' studies for the JO CO JS&PSS Issue, including other counties' interests, through OSU's Rural Studies Program. The AOC is on our list of stakeholders to contact at the same

level of interaction that we attempted to contact you, and we appreciate your agent's suggestion to a specific AOC contact, Paul Sieng, Public Safety Policy Manager.
